

Shoreland Volunteer Position Description University of Minnesota Extension Service-Cass County

TITLE: Shoreland Volunteer

GENERAL DESCRIPTION: The University of Minnesota Extension Service – Cass County coordinates instructional resources, training, and technical and administrative support for the Shoreland Volunteers. Shoreland Volunteers share the information gained by the program with interested community residents to develop good stewardship practices aimed at preserving, improving and enhancing water resources.

EXPECTATIONS:

- To attend all Shoreland Volunteer training sessions for learning.
- After the initial training, volunteer for a minimum of 20 hours targeted at improving surface water quality.

DUTIES:

- Be a continuous learner.
- Be a water quality educator in the community.
- Demonstrate best management practices.
- Answer questions and inquiries (by telephone, demonstrations, one to one visits, and/or workshops) from the
 public on water quality issues such as septic systems, lawn care, aquatic vegetation, monitoring, shoreline
 protection and related topics.
- Staff question/answer/display sessions at public locations (lake days, fairs, annual meetings).
- · Cooperate with and assist the county and cluster staff.
- Assist in the preparation and production of specific educational resources.
- Keep appropriate records.
- Provide feedback and input to enhance the Shoreland Volunteer Program.

QUALIFICATIONS: Willingness to learn about surface water quality. Willingness to share approved resource materials and information with others in community. Ability to work with extension staff. Good communication skills.

RESPONSIBLE TO: Cass County Extension Educator, Natural Resources and Environment.



Have you ever wondered how lakes were named? With 10,000+ in

creative, or in some cases quite basic - Woman, Child, Girl, Boy, etc. I've heard that Washburn was named for a lumber baron who lived/worked on the lake. True or not, I've also wondered why some lakes have "Lake" first. Why is it Lake Calhoun, Lake Minnetonka, Lake Mille Lacs; but Bay Lake, Leech Lake, Gull Lake, etc.? Now, Washburn, I've actually heard both ways, but usually Lake Washburn.

Have you ever wondered about some of the resorts on our lake? Bear Paw Lodge is a very interesting-looking place that seems to have a lot of character. Lisa Botts of Golden Valley (and Lake Washburn) wrote to me and shared her childhood memories of spending summers there.

"Around forty years ago, my mother and father started coming to Lake Washburn to stay at Bear Paw Lodge for our summer vacations. I have so many wonderful memories of our summers back then; swimming and fishing, water skiing, and horse-back riding at a stable on Roosevelt Lake. One summer we had such an incredible northern lights show, that newspapers reported it as far away as Michigan! We went there for many years. We were even there the day after that huge tornado in 1970 that ripped through the area. I remember seeing the devastation from a float plane. My riding stable was pretty wrecked up, too. Soon after that, my dear father passed away and we couldn't go back. No more Lake Washburn, no more Bear Paw Lodge, but I never forgot our good times on the lake. After marrying in 1979, I dragged my husband back up North to see if Bear Paw was still there. To my delight, nothing had changed! Many new memories were formed as I watched my children run, swim, fish, and play in the same spots as I did as a child. Then in 1991, we were able to buy a little cabin on Longwood Point, near where Dagget Brook enters from Lake George. Our family memories continue to grow and expand as we enjoy Lake Washburn from the northern shore. Bear Paw Lodge is still up and running, too, and sometimes we still spend a week there just for old times sake. I am so thrilled that my family legacy of 'going to Lake Washburn' can continue on for my kids, and that they can have the same kind of joy I had growing up."

Thanks, Lisa. What fabulous memories you have of Lake Washburn over the years! A footnote to this story: The owner of Bear Paw, Mae Witkus, passed away on August 5th, 2002.

Oh Deer, Bad Hair Day!

Male deer grow new antlers each year. They begin as soft bumps on the head in the spring. They grow quickly but stay soft and tender until late summer. Then the velvet dries, and the antler gets hard as bone. The male deer scrapes its hard antlers against trees to remove the velvet and expose the tines. Young male deer grow small antlers with two points. Older deer grow large antlers with six or more tines. In mid-winter the antlers fall off. Mice and squirrels often eat the "sheds"

for the nutritious minerals. When walking in the woods have you ever found fallen antlers?

GOOD BYE TO OUR LOONS FOR ANOTHER SEASON

As the loon population prepares to leave Minnesota for their southern wintering grounds, here is some information provided by the Loon Watch Program at the Sigurd Olson Environmental Institute, Northland College, Ashland, Wisconsin.

· Loon chicks remain on lakes in the north after the adults leave. They need as long as possible to complete their growth and increase their strength. The longer they wait to migrate, the more experienced they will be in caring for themselves. If the lake freezes before they get off, the chicks will not survive because they need a "runway" of at least 1/4 mile to take off from the water.

· Loons migrate to the ocean instead of spending the winter on inland lakes that don't freeze. They don't go to inland lakes because a new set of dangers awaits: preying alligators, water that is too warm for loons, or too shallow and murky for diving and hunting. Loons need VERY clear, deep, open water for diving and catching fish. The ocean is the right place for loons in winter.

· Loons are equipped to expel the salt from their system taken in from eating salt water fish and drinking salt water. They have a pair of glands above their eyes which expel the salt taken in from seawater. These drip almost constantly during the winter season.

· Loons are silent in the winter in the south. Although loons have been heard giving yodels and tremolos on the wintering grounds, it is not common. It probably is because the hormone levels are not high enough.

· Loons typically eat what they catch while still underwater, but based on observations of food brought to the surface, during the winter loons eat flounder, crabs, lobster, gulf menhaden, bay anchovies, and silversides. During the summer, the loons favorite food is yellow perch, but they will eat whatever is available and what they can catch.

LAKE WASHBURN ASSOCIATION MINUTES General Meeting - August 10, 2002 Outing Town Hall - 5:00 PM

The August general meeting was held on Saturday the 10th at 5:00 p.m. in the Outing Town Hall. Approximately 55 members attended the Ice Cream Social. Owls & Things donated the ice cream, which was enjoyed by all participants. The membership expressed appreciation to Owls & Things.

The guest speaker for the evening was Tim Brastrup, Area Fisheries Supervisor with the DNR in Brainerd. Tim's talk centered on the fishing and stocking questions related to Lake Washburn. Starting in 1999 our lake has been participating in a 5 year no-stocking program. Each fall Tim's department "electrofishes" our lake to take a count, evaluate the varieties of fish taken, etc. Tim seems to believe that natural reproduction is taking place and that although our lake has an abundance of northern, the other fish such as walleye, perch, bass, etc. are also propagating. During the summer of 2003 the DNR will be taking a catch rate to determine if fry or fingerlings will be planted into our lake. Also, due to the predatory nature of the northern, Tim suggests that a sign should be put up at the boat landing (by the DNR) stating the certain lengths of northern to be released. It was suggested that we mention this matter in our newsletter. (We can obtain specific wording from the DNR office.) During the question and answer portion, matters related to retaining the bulrushes as a habitat for fish was encouraged. In fact, Tim noted that he felt LWA could enhance our lake's fish population more by developing a good bulrush retention program than by planting more fry! Related to the 3 islands, it was reported the BLM has turned over management of these islands to the Department of Fisheries...and Tim will be evaluating the 3 islands relating to public usage, etc. Finally, with respect to a question on loon nesting. Tim suggested that interested parties phone Pam, Perry, or Kevin in the Brainerd office (218-828-2228). The membership thanked Tim for his fine presentation.

The formal portion of the General Meeting was called to order by President Doug Johnson. The minutes of the June meeting were reviewed. LaVon Heston gave the Treasurer's report. The total assets of LWA are \$19,345.34. Our membership stands at 168.

OLD BUSINESS:

County 48 Cleanup: Paul Cartwright reported that 18 members participated, and it took 1 hour. The Labor Day cleanup will be August 31 at 9:00 a.m.

LWA Website: Mary Hildreth reported that our website is

up and running. He gave the www. information and indicated that we are in the early stages of establishing this site. Buoy markers: It was noted that due to the "aging process" we need more and younger volunteers. LWA may need to a hire a person to put in/take out buoys if we cannot develop more volunteers. Another option would be if our association discontinues any involvement with buoys in/out. Dry Well Motion: Mark Hegman read this motion related to LWA contributing \$500 from our operating fund and an additional \$100 (from the "designated" fund) towards this project. We are inviting Len Lang or designee to address a general meeting in 2003 in order that the general LWA membership fully understand exactly where the dry well program is leading in so far as Lake Washburn is concerned. Pine River Watershed Association: Dave Snesrud reported that although LWA has agreed to pay dues of \$100, we are still only 1 of 6 lakes continuing to support this association. The concern related to our need for water testing was discussed. Dave also noted that our association must become more active in LIMNOLOGY and all matters related to water. **NEW BUSINESS**

Doug Johnson announced the following: Changes in canister pickup procedures, loon nest matters are being looked into, we need much volunteer help to produce our newsletter.

Nominations: Don Peterson announced the slate of officers and directors being proposed. He asked for additional nominations from the floor. There being no other nominations, the following nominees were unanimously elected: President: Dave Snesrud, VP: Ron Nichols, Secretary: Mark Hegman, Treasurer: George Fortmeyer.

Additional Directors elected: Rollie Hirman, Jim Lindahl, and Cliff Waters.

The meeting was adjourned at 8:00 p.m.

It will soon be that time of year. Please drive your snowmobile safely and considerately.

BE SURE TO:

- · Wear a helmet, eye protection, and proper clothing.
- Tell someone where you are going and when you expect to return.
- Let weather, lighting, and trail conditions determine a safe speed.
- · Ride straight no alcohol or drugs.
- Reduce your speed when riding at night to less than
 MPH
- Stay clear of thin ice and lake inlets never cross open water.
- · Never ride alone use the buddy system.
- · Stay on groomed area of trails.
- Obey speed limits maximum speed in Minnesota is 50 MPH.
- Make sure any youth operating your snowmobile has a safety certificate.
- · Check local ordinances on when and where you may ride.

Don't "overdrive" your snowmobiles's headlight. When going too fast, it can take a much longer distance to stop than your headlight shines. Many fatal snowmobile accidents occur because the machine was traveling too fast for the operator to stop when the headlamp illuminated the danger.

ALWAYS RESPECT PRIVATE LANDS - ASK FIRST!

Always ask first before entering private lands, even if it's not posted. Just because property isn't posted, that doesn't mean you have a right to enter someone else's private property. By respecting others' privacy, you will improve relationships between landowners and snowmobilers.

DNR RELEASES RESULTS OF DEER & ELK CWD TESTING

The Minnesota Department of Natural Resources has received results from 25 Chronic Wasting Disease (CWD) tests done on deer in the Aitkin area surrounding the elk farm where a male elk died of the disease. All have been negative. In addition, the DNR received results on 10 deer from around the state that were tested in the agency's on going surveillance program. Those results were also negative.

Elk from the Aitkin farm are continuing to be tested. So far 27 results have been received, all negative. As of October 10th no other elk on the Aitkin farm have shown symptoms of CWD. However, state animal health officials decided to euthanize the entire herd.

Meat from deer or elk should be safe to eat, according to officials at the Minnesota Department of Health, provided that

hunters take the following precautions:

- · Don't eat meat from animals that look sick.
- Don't eat the brain, spinal cord, eyes, spleen, tonsils and lymph nodes.
- Dress the animal properly minimize handling of brain and spinal tissues, wear rubber gloves when field dressing carcasses and wash hands and instruments thoroughly after field dressing is complete.

Chronic Wasting Disease (CWD) is a fatal brain and nervous system disease found in elk and deer in certain parts of North America. The Disease is believed to be caused by an abnormally shaped protein, which can damage the brain and nerve tissue. Animals infected with the CWD show chronic loss of weight, and become emaciated. Other symptoms include staggering, drinking large amounts of water, excessive urination, and drooling. Should you see an animal you suspect is sick, do not shoot it. Report it to the local conservation officer or area wildlife manager. The DNR will attempt to locate the animal and have it tested for CWD.

The DNR is releasing updated CWD test results weekly on Tuesdays. However, if a positive test is found, DNR officials will move quickly to notify the public.

PRWPF UPDATE

The Pine River Watershed Protection Foundation has been staffed by volunteers and donations. The task of protecting the watershed has increased and requires more time and effort. The PRWPF would like to have one full-time paid person oversee and run the program. They have proposed a joint powers agreement between Cass and Crow Wing Counties which would provide funding to do this project. It is in the Counties' best interests to protect the water quality of the lakes. When the water quality decreases, so do property values, which will then erode the tax base.

This fall there have been substantial differences in the Secchi disk readings between the North and West basins of Lake Washburn. Over the past 3 years the biggest difference has only been 1 foot. On September 16th of this year, the North basin's reading was 14' and the West basin's was 10-1/2'. On October 5th, the North was 17', the West 9'. According to Bob Becker, head of the PRWPF, the most likely reason is an algae bloom.

FACTS TO NOTE: Run-off from 1 acre of natural, undisturbed shoreline will add 0.13 pounds of phosphorus per year to a lake. Compare that to 1 acre of unfertilized sloping lawn, which will add 1.2 pounds of phosphorous. . .9-1/2 times more! Each pound of phosphorous can generate 500 pounds of algae!





DANGER! THIN ICE!



4" of new clear ice is the minimum thickness for travel on foot

5" is minimum for snowmobiles and ATVs

8" - 12" for cars or small trucks

(Remember that these thicknesses are merely guidelines for new, clear solid ice. Many factors other than thickness can cause ice to be unsafe.)

Check for known thin ice areas with a local resort or bait shop. Test the thickness yourself using an ice chisel, ice auger or even a cordless 1/4 inch drill with a long bit.

Refrain from driving on ice whenever possible. If you must drive a vehicle, be prepared to leave it in a hurry-keep windows down, unbuckle you seat belt and have a simple emergency plan of action you have discussed with your passengers.

Stay away from alcoholic beverages. Even "just a couple of beers" are enough to cause a careless error in judgment that could cost you your life. And contrary to common belief, alcohol actually makes you colder rather than warming you up.

Wear a life vest under you winter gear. Or wear on e of the new flotation snowmobile suits. And it's a good idea to carry a pair of ice picks that may be home made or purchased from most sporting goods stores. It's amazing how difficult it can be to pull yourself back onto the surface of unbroken but wet and slippery ice while wearing a snowmobile suit weighted down with 60 pounds of water. CAUTION: Do NOT wear a flotation device when traveling across the ice in an enclosed vehicle!

Before venturing out on a frozen lake or pond, keep in mind:

THERE IS NO SUCH THING AS 100 PERCENT SAFE ICE!
